

# **Official Giveaway Rules**

Giveaway entrants are responsible for reviewing and understanding these Official Giveaway Rules prior to entering the Giveaway. By entering into the Giveaway (defined below) you accept the terms and conditions of these Official Giveaway Rules and agree to be legally bound by them.

Logitech Europe S.A. and its respective associated companies, affiliates or subsidiaries are not responsible for the administration of the Giveaway, the collection or processing of entries or the selection of winners.

Logitech Europe S.A. has provided prize(s) and/or the use of its name(s) and trademark(s), as applicable, but is not involved in the execution or administration of this promotion. TO THE EXTENT PERMITTED BY APPLICABLE LAW, ENTRANT AGREES TO RELEASE AND HOLD HARMLESS LOGITECH EUROPE S.A. - 2.2. The Giveaway computer system is used to govern all computer and time-related aspects of the Giveaway and is the official time-keeping device for the Giveaway.

## 3. How to enter Giveaway

- 3.1. NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER THE GIVEAWAY. Here are the instructions to enter the Giveaway:

  - Use the left (<-) and right (->) arrow keys to navigate your mouse as it races straight ahead on the desk.

- 8.8.** Any attempt to deliberately damage any website or to undermine the legitimate operation of the Giveaway is a violation of criminal and civil laws.
